Hello supporters of the Oregon Paleo Lands Center.

Even in these challenging times, your Board continues to work to share the wonders of the John Day Basin and provide services for interested citizens.

We managed to weather limited 2020 operations pretty well with support from the Bank of Eastern Oregon, Oregon Community Foundation and the Wheeler County Cultural Coalition through the Oregon Cultural Trust.

It appears 2021 is not going to be quite as normal as we were hoping. When we open the Center this year, we will continue to utilize the most current safety protocols. Masking, spacing and cleaning will be the foundation for welcoming in-person visitors. We plan to reopen for six months, starting Memorial Day Weekend, May 28, just in time for the Spray Rodeo and to assist some exciting regional events like Cycle Oregon, in Fossil and Mitchell (Sept 11-18th) Our work continues to focus on maintaining our fine building, in a County with some of the least financial resources in Oregon. Securing \$4000 to re-stain the Center is our highest maintenance priority. We expect to apply again for federal payroll support as well as pursue additional support from charitable organizations such as the Oregon Community Foundation in the next few months.

I am pleased to report that we are expanding our Board volunteer base! We secured a new skilled communicator to our Board that has demonstrated a willingness to work with our small Board. Steve Lundgren is a self proclaimed rock nerd with years of news reporting experience in Central Oregon.

Through an Oregon State Parks Heritage grant, your Board is working with, The Alchemy of Design, to produce A River Flows Free, a new video/exhibit that will showcase the past 10,000 years of life in the John Day River Basin. This new exhibit will show at the Center for visitors to enjoy and be offered up on our website.

Our website www.oregonpaleolandscenter.com continues to evolve, offering up new information to interested citizens. New features include a downloadable file highlighting the John Day River Food Trail, created by the John Day River Territory Group, informational files highlighting the Oregon 150 birthday exhibit created in 2009 by the State of Oregon , Bureau of Land Management links to maps of the proposed Sutton Mountain and existing Spring Basin Wilderness areas as well as the John Day River mainstem and North Fork regions, along with our Backcountry Cycling Guide to Wheeler Co.
